The phantom stock will be payable in a lump sum upon the death of the Reporting Person or a change in control of Issuer prior to the time all payments in respect of the phantom stock have been paid to the Reporting Person. The award will be paid in cash. The value of the phantom stock will be determined based on the Issuer's share price at the time of payment.

2. For the avoidance of doubt, the share number and price per share in this report do not reflect the stock dividend to be effected by Issuer in connection with the closing of the initial public offering.
